Sewer Video Program

In a past newsletter, I wrote a short article in regard to the success and demand of one of our IRWA internal services...that of the GPS-GIS Mapping Program. It continues to grow, and we get more requests for water, wastewater, and storm sewer mapping of rural utilities.

In that article, I made mention of one of our other internal programs, which is the Sewer Video Inspection service. That program has been used many times over the past four years, for "one-day" short runs through system sewers, but the larger projects started out strong, and then went through some time of less demand. However,

recently, we have been getting more requests for proposals of major projects within various systems in the state.

In late July, IRWA completed the first phase of a larger sewer video project for the Village of Tampico, located in Whiteside County, in northwestern Illinois. And, we will complete the second, and last phase of that job

when the community is ready, after doing some line cleaning. The total footage to be surveyed, is just over 10,000 linear feet. Tom Pierce, the Village Public Works Director, has used our service before, and has been very pleased with the results, not only while on the job, but in the end with the videos and graphic reports provided to the utility.

Most recently, the Association has provided the service, per their request, to the Village of Gridley, which is located in the north-central part of the state in McLean their sanitary sewer system inspected a couple years ago. But in October, after receiving an IRWA sewer video proposal, the Board once again moved forward to complete the last phase of the project. Initially,

IRWA had inspected about a third of the utility's sewer system...so, they wanted to get the remaining balance viewed and reported on.

With the help of Superintendent Dennis Stauter, and his assistant Dan Garretson, we made good use of unusually nice weather and the overall good integrity of the collection system, to complete the remaining 25,000 feet of inspection in just a little over half of the projected time to do so. As such, we were able to save the community thousands of dollars by cutting expenses for the project. In the end, we provided the town with

good video of the lines inspected, as well as two different graphic hardcopy With the help of Superintendent reports for them to utilize in the manner they need. Also, in regard to Gridley, Dennis Stauter will be retiring at the end of the year, after supervising the community's utitlities for many years. Dan Garretson, who has been on board for several years himself, will assume the Superintendent's position in that community. IRWA, and I personally, wish Dennis the best in his retire-

> ment, and want to again pass on the best to Dan, as well. Both of these men, were very integral into helping our staff complete the project in Gridley, in a good, efficient, and cost saving manner. We appreciate it.

So, in ending, don't hesitate to contact me directly, if your community is looking or needing to do sewer video inspections in the coming year. I would be more than happy to talk with you, about what we can do to be an asset to your utility, at the most reasonable price we County. Just as Tampico, the community has had part of can. As I tell everyone, getting a proposal, doesn't cost a thing!

day. There are many times I spend nights in hotels. One of In my job duties, I have performed several leak locates this past year. Each time I do one I learn some new tricks of the trade. There have been some that have been difficult and interesting. I was called about a leak where the community was losing 100,000 gallons of water per day and there were no signs of water coming to the surface. I met with the operators and reviewed some maps and came up with a plan. This was a rural water system and that can make a challenge with locating water leaks. They had narrowed it down to a smaller area by shutting valves. They had also found chlorine residuals in a pond. I finally found the leak. It was at a reducer before going into a vault with gate valves. When the pipe was installed they had put concrete over the reducer so it was never going to allow the water to come to the surface.

> I have also done a handful of operator certification reviews for water operators. When I receive the call that the employee has passed the exam it is a good feeling. I always tell the operator if they do fail the test to not get discouraged. They can always retake the exam on the next available date. If someone in your system needs to be certified, give us a call and we are happy to help.

FLUORIDE RULE CHANGE NEW TARGET - .7 mg/L

The new fluoride rule that we have all been hearing rumors about has now been finalized. The new target for fluoride is now .7 mg/L and was published in the November 20, 2015 Illinois Register with an effective date of November 9, 2015. Therefore Illinois water supplies should now target .7 mg/L rather than the former .9 - 1.2 mg/L range.

GPS/GIS MAPPING SERVICES

Through the implementation of GPS & GIS technology, IRWA can effectively produce hard copy and digital maps. With this new service available from IRWA, utilities can attain new and accurate maps to better manage their infrastructure assets.

The printed maps can be large-scale wall maps up to 36"x48" showing major water and wastewater features with the desired layers (aerial photos, streets, topography, etc.). The printed maps can also be gen-

erated into a map book format. The map book is a bound 11"x17" book of high-detail maps printed at the best available scale.

The digital map file on a CD, can be viewed and printed with free software that IRWA will provide. The software allows you to click on a waterline with a leak and highlight which valves need to be closed to isolate the line. There are also tracing features to show the direction of water flow, and other useful features.

Payment for services is determined by a charge per each system feature located. The amount charged for a Map Book will be \$50 plus \$5 per page; and a wall map is billed at \$100 per map. More information is also posted on our website at www.ilrwa.org or you may call our office at 217-287-2115.
